Bernard J. Lawlor, 94, husband of the late Jean Burgh Lawlor passed away on Thursday, July 27th, 2017 in Florida where he had resided for many years. Born Dec. 13, 1922 in New Haven a son of the late Bernard J. and Mary Potter Lawlor he was a graduate of Hillhouse High School and the University of New Haven from where he earned a degree in Criminology. He was a US Navy veteran of WWII. He joined the New Haven Police Dept. in 1951 and rose to the rank of sergeant captain of the Detective Division. He then joined the New Haven State Attorneys Office in 1967 and worked there until 1975 when he transferred to the Middletown Office. He retired in 1987. Bernard was a member of the American Legion, The Elks Club and the Knights of St. Patrick. He is survived by two daughters , Siobhan Matsagas and husband George of Newtown, PA and Kathryn Miller and husband Pete of Glasgow, KY, three grandchildren, Jennifer Pozika and husband Michael, Christopher Matsagas and Patrick Matsagas, a brother Terrance Lawlor of Branford , a sister Mary Beth Claflin of Fairfield and several nieces and nephews. He was predeceased by a daughter Colleen Lawlor and two brothers James Lawlor and Kevin Lawlor.

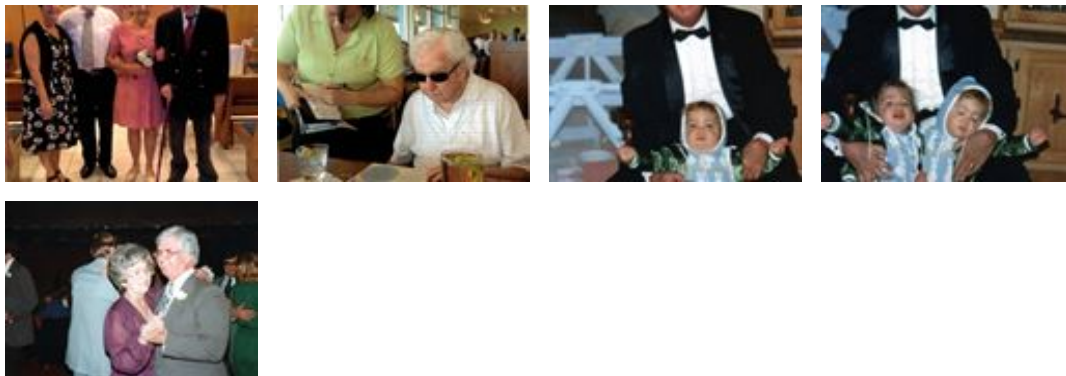
